Guidelines for the award

Benefits for low-income families and individuals





### **What is the Family and Culture Pass?**

The Family and Culture Pass of the City of Backnang (FKP) helps low-income families and individuals to participate social and cultural life.

### **Who can get such a pass?**

The pass is issued to persons who live in Backnang and whose household members together do not exceed a certain income limit. The pass is then issued to each family member from the age of 7.

### **What is the benefit of the Family and Culture Pass for the eligible persons?**

The Family and Culture Pass of the City of Backnang includes numerous discounts that are meant to make life in Backnang easier for eligible families and individuals.

### **For how long is the pass valid?**

The Family and Culture Pass is always valid for one year.

However, at the end of the year it can always be renewed for another year, as long as the conditions are still met.

**Discounts of 50 % are available through the Family and Culture Pass for the following events and tickets:**

- Individual events of the Backnang community centre and the city gallery
- Single tickets for the Murrbäder sports and family pools Backnang Wonnemar
- Single tickets for the open-air swimming pool for children, adults and families
- Swimming courses in the Backnang pools

**A discount of 50 % is also possible for the following contributions and fees:**

- Membership fee for a variety of sports and music clubs
- Parental contributions for all day-care facilities, the morning childcare services at primary schools and after-school care
- Annual fees at the public library
- Lessons at the Youth Music School/Arts School
- Courses at the Backnang Adult Education Centre up to a maximum of € 300 per person

**Recipients of the education and participation package may be excluded from these benefits.**

### Purpose(s) of data processing, legal basis:

The data processing is based on Art. 6 (1) lit. a GDPR. It is carried out for the purpose of issuing the Family and Culture Pass of the city of Backnang, as well as for statistical purposes.

### Planned storage period:

The data is collected immediately in order to fulfil the above purpose and will be stored for at least one year, the period of validity of the pass. If you do not apply for a renewal, your data will be deleted at the latest 1 year after the expiry date.

### Recipients or category of recipients of the data ( offices to which the data will be disclosed:

Your personal data will only be disclosed to the Office for Family, Youth and Education.

### Rights of data subjects:

As a data subject, you have the right to obtain information from the municipality about the processing of personal data (Art. 15 GDPR), to the correction of incorrect data (Art. 16 GDPR), the erasure of data (Art. 17 GDPR) and the restriction of processing (Art. 18 GDPR), provided that the legal requirements for this are met. You may request to receive or transfer the personal data provided in accordance with Art. 20 GDPR. You can lodge an objection in accordance with Art. 21 GDPR. You can withdraw your consent to the processing of your data at any time. Without prejudice to other legal remedies, you may lodge a complaint with the State Commissioner for Data Protection and Freedom of Information, P.O. Box 10 29 32, 70025 Stuttgart, [poststelle@lfdi.bwl.de](mailto:poststelle@lfdi.bwl.de).

### Obligation to provide data, consequences of refusal:

You are not obliged to provide the personal data. If you do not agree to this, your application can neither be examined nor can the Family and Culture Pass of the City of Backnang be issued.
